

**2010 Blueberry Jubilee  
General Information**

- Craft spaces measure approximately 12 ft. by 12 ft. and food booths are approximately 12 ft. by 20 ft.
- Space fee is \$50.00 for arts and crafts booths and non-profit food booths and \$100.00 for Commercial booths and Profit food booths. (Check or Money Order)
- Final deadlines for applying are:  
**Craft** - May 1, 2010 (Returning vendors wanting same spot)  
 June 5, 2010 (New Vendors)  
**Food**- April 10, 2010 (Returning vendors wanting Same spot, if available)  
 May 1, 2010 (New Vendors)  
 (Spaces are limited)  
**A \$25.00 late charge will be charged for any applications received after June 1 for Craft booths or May 1 for Food booths.**
- An application is a commitment to show with no refund for cancellation.** Spaces are not transferable so you cannot sublet your space.
- This is a family-oriented Jubilee and work must be in keeping with the atmosphere. The Jubilee Council has sole discretion for removal of work violating Jubilee rules.
- The Blueberry Jubilee Council will not be responsible in any way for damages to the work or persons participating in the show. Limited overnight parking available.
- Photos required: Submit 3 photos of your work. Enclose a 10-inch stamped, self-addressed envelope for return of photos and notification.
- Entry fee, pictures, and a 10-inch stamped, self-addressed envelope must accompany application. Checks will be deposited upon acceptance. Should your application be rejected, your check will be returned promptly. No postdated checks will be accepted.
- Setup time:  
 Friday: June 11 (5:30 p.m. to dark)  
**Absolutely no setup before 5:30!!! Vendors setting up before this time will not be accepted in the future.**  
 Saturday: June 12 (6:30 to 7:30 a.m.)  
 After 7:30 a.m. please park in vendor designated areas. (Map will accompany acceptance notification.) **No vehicles will be allowed to remain in the area. Vehicles in the area between 7:30 a.m. - 4:00 p.m. will be towed at the owner's expense.**
- Take Down Time: June 12 (4:00 to 5:00 p.m.)  
**No vehicles will be admitted in area before 4 p.m. Vendors that attempt to pack up or enter**

**the area before 4 p.m. will not be accepted in the future.** Return tax envelope to the information booth at MS Power Building. **Taxes must be paid by check. Cash will not be accepted.**

- No wearing apparel bearing "Blueberry Jubilee" will be sold except by the Jubilee Council.

**Categories:**

**Crafts-**

Painting, drawing, graphics, sculpture, pottery, dolls, weaving, quilt-making, original needlework, crafts, woodwork, handmade jewelry, metal work, basket-making, etc. **Commercial items are not allowed to be mixed with crafts. If commercial items are in booth, vendors will be asked to remove them. If not removed from booth, vendor will be asked to leave and will not be accepted in the future.**

**Commercial Booth Displays-**

This group is for specialty items approved by the Jubilee Council. **Items that compete with crafters will not be allowed.** No display will be allowed to block other vendors from being seen.

**Food Booths-**

Booths are for one day only. Each vendor is allowed to sell one main food type. If duplication occurs you may be asked to change food selection requested based on date application was received. You furnish your tables, tents, chairs, etc. You are expected to clean your area after the completion of the day. Please bring at least one table with chairs for the public to use while they eat and drink. Food booth vendors are expected to remain open all day. Electricity is available, (110 volt 15 amps) but you must furnish your own extension cords. (Limited 220 volt 50 amps stove plug available at additional rate. **Absolutely no direct connections allowed.**) No other ampage is available other than 15 or 50 amp.
